SUBJECT: 2009-2015 GTS 150, GL 150 AND GTS PLATINUM FUEL TANK REPLACEMENT

PURPOSE:

All 2009-2015 GTS 150, GL 150 and GTS Platinum models may have been manufactured with a fuel tank that does not meet Hammerhead Off-Road quality standards. The fuel tank may develop a crack and result in a fuel leak. To address this concern, an updated fuel tank and support bracket kit has been developed to be installed on affected units.

Your service department **MUST** perform the following actions as directed by this Safety Bulletin:

- 1. Each member of your service department team must review this Safety Bulletin in its entirety.
- 2. Each member of your service department must watch the training video prior to completing **ANY** work, or submitting **ANY** warranty claim for this Safety Bulletin.

The VIN label can be found on the cross bar behind the seats as shown. VINs starting with L6KDB, L6KSAL or L6KSAK are affected.



Vehicles with this bracket installed are not affected, or have already been updated.

CUSTOMER NOTIFICATION

Dealers are required to review their sales records and make arrangements with customers for Safety Bulletin completion. In addition to customer units, dealers are required to correct any affected units in their inventory. Hammerhead Off-Road will be mailing a Safety Alert notification letter to consumers affected by this Safety Bulletin in the United States. WARRANTY CLAIM / PARTS INFORMATION

Dealers must submit a Warranty Labor Claim form along with a completed copy of the HH13-01 Bulletin Completion Instructions & Dealer Confirmation form for reimbursement after performing the repair on an affected unit. Templates of the parts order form and warranty labor claim form can be found at the end of this Safety Bulletin.

Dealers are also required to print out the associated recall notice poster and display it in an area of your dealership that is visible to customers such as the entry door, cash registers, bulletin boards, or other high traffic areas. The poster must be displayed until the date noted at the bottom of the poster. HH-001 TWO-PART PROCEDURE

IMPORTANT
Several steps of this procedure require an audit by another dealership representative other than the technician who is completing the repair. Completing these check backs is a critical component to ensuring the repair has been properly completed.
An audit checklist will be provided with each kit. It must be completed and retained with the instruction sign-off and repair order.
AUDIT CHECKLIST
Inspect for proper bracket adhesion across all surfaces including the rear portion of the bracket.

Ensure the hardware was installed in the correct order and the fasteners were properly torqued.

Ensure the fuel and vacuum hoses were properly reconnected and the spring clamps are in place.

TWO-PART PROCEDURE

PART 1: REMOVAL

Tools Required:

- For Removal:
 - o 12 mm Wrench
 - o 10 mm Socket.
- For Installation:
 - Side cutters
 - o 10 mm Wrench
 - o 10 mm Socket
 - o Torque Wrench

NOTE

Allow the engine to cool before servicing.

- 1. Safely drain fuel from existing tank.
- Hold a rag under the fuel lines to prevent any fuel from spilling into the engine area and disconnect the fuel pickup hose ① from the fuel filter, and vacuum hose ② from the three-way junction.



3. Using a 12 mm wrench and a 10 mm socket, remove the four fuel tank mounting bolts ④.



IMPORTANT

Be sure to keep the R-washers (5) to be reused when installing the new tank.

4. Remove the fuel tank from the vehicle and discard it along with all hardware (except R-washers (5)).

NOTE

Dispose the fuel tank as required per local regulations.



PART 2: INSTALLATION

IMPORTANT

The mounting bracket is adhered to the new fuel tank and should not be separated. Ensure the bracket is fully adhered to the fuel tank in all areas shown.

IMPORTANT – AUDIT STEP

A secondary dealer representative must verify that the support bracket is fully adhered to the fuel tank in all applicable areas.

5. Cut and remove the two Panduit straps that came installed on the new tank assembly.

6. Place the tank/bracket assembly into its mounting position.

NOTE

Do not reuse the fuel tank that was previously removed.

Install the four flat washers in the gap between the tank and bracket as shown.

8. Install the four fuel tank collars from the top side of the tank.

NOTE	
Collars should sit on top of the washers.	

9. Install a washer onto each of four bolts and insert bolts through the frame.

Loosely install the four R-washers and nuts from the bottom side of the frame.

NOTE

Ensure the arced side of the washer is seated in-line with the frame tube.

11. Using a 10 mm wrench and socket, torque bolts to specification.

NOTE

There will be a gap between the support bracket 6 and the fuel tank flange 7.

TORQUE

Fuel Tank Bracket Fasteners 8 ft-lbs (11 Nm)

IMPORTANT – AUDIT STEP

A secondary dealer representative must verify that the fasteners were installed in the correct order and the fasteners were torqued to specification. Mark the nuts with a paint pen to indicate the audit has been completed.



- 12. Install the fuel pickup hose (8), vacuum hose (9) and spring clamps.
- 13. Add fuel to the tank, start the vehicle and inspect for any leakage.

IMPORTANT – AUDIT STEP

A secondary dealer representative must verify the fuel pickup hose, vacuum hose and both spring clamps are correctly installed.
